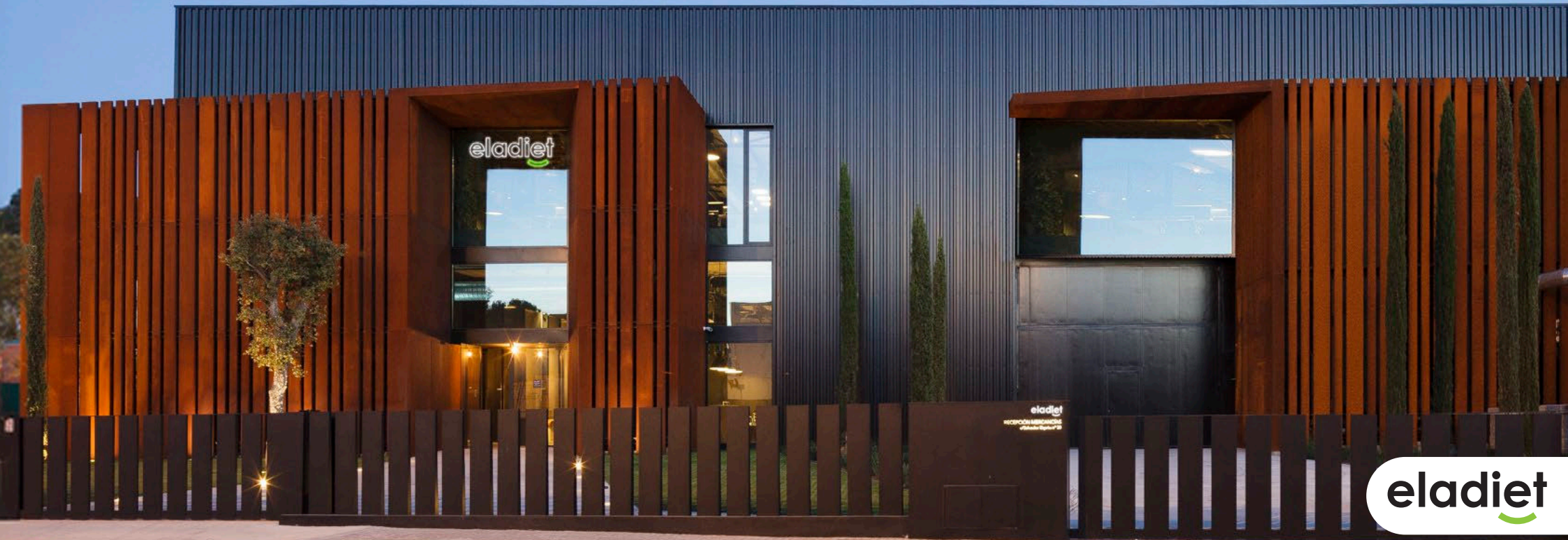

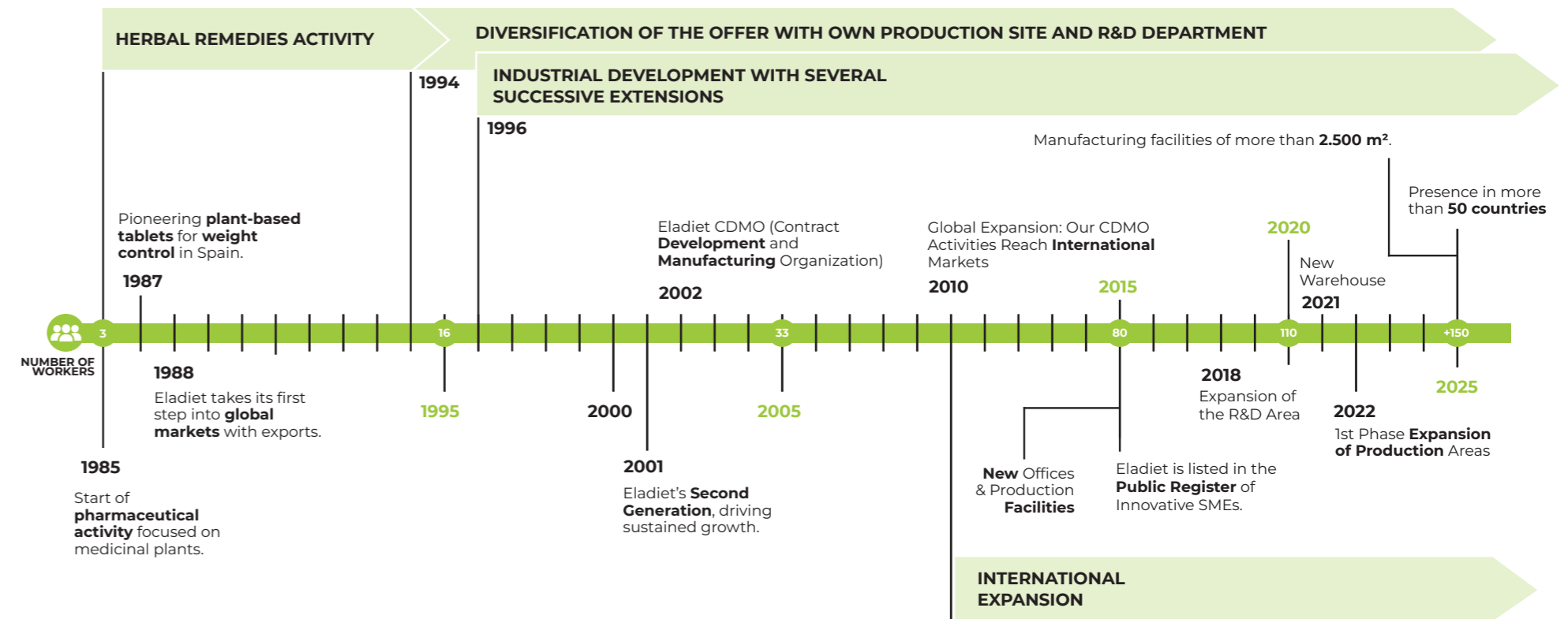

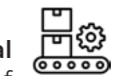
Research & Development

At Eladiet, we believe that protecting the environment is not a choice - it's a responsibility. For more than 10 years, we have been actively working to minimize our environmental footprint, integrating sustainability into every area of our operations, from energy use to materials selection and logistics.

Our key environmental actions include:



Paperless offices: We have digitalized our internal processes to significantly reduce paper consumption (Paper Office 0).



Renewable energy: Between 40% and 50% of our energy consumption is now covered by solar photovoltaic systems installed in our facilities.



Eco-friendly printing: We use FSC-certified paper and water-soluble inks to ensure more sustainable communication and packaging.



Waste management: We apply a structured waste management programme that prioritizes reduction, separation, and responsible disposal.



Sustainable mobility: Our corporate fleet is being gradually replaced with hybrid vehicles, reducing CO₂ emissions from daily operations.



Sustainable packaging: We are actively testing and validating alternative materials such as PVC, PVDC, PE, and others to minimize environmental impact while maintaining product integrity.



Environmental governance: In 2022, we appointed our Chief Engineer as the person responsible for environmental health and safety, reinforcing our internal accountability.



Sustainability commitment: Sustainability commitment: The EcoVadis badge and ISO 14001 certification highlight our commitment to environmental responsibility, continuous improvement, and sustainability.

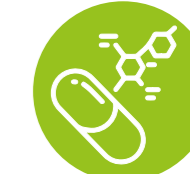
